

“MAD WARRIOR” WAIVER AND RELEASE

In consideration of the acceptance of my offer to participate in some or all of the adventure activities described herein, I have read, understood, approved and agree to the following provisions.

In this waiver and release form, the expression “adventure activities” means all activities, events, services & use of facilities either provided by or arranged by Mad Warrior, a division of Tadam Hill Adventure Sdn Bhd (TASB), includes officers, employees, agents and contractors of TASB. This waiver and release applies to all adventure activities which I participate in, whether in the past, present or future.

Please read and agree to the following:

1. I accept that adventure activities carry with them a degree of risk. I expressly agree to assume the risk of personal injury to myself and to persons for whom I am responsible for supervision and care, as well as the risk of damage to property while participating in the adventure activities
2. I release TASB from all claims, losses, damages or expenses, which may be incurred by me as a result of the negligence of TASB.
3. I indemnify TASB against all claims, losses, damages or expenses that may be made by any persons for whom I am responsible for supervision and care as well as persons who may make such claims on my behalf.
4. I am physically fit and have no condition or injury that could be affected by the adventure activities.
5. I consent to any medical treatment which may be considered necessary by TASB in the event of injury or illnesses during the course of undertaking adventure activities and I agree to indemnify TASB in respect of the cost of the medical treatment.
6. I understand that TASB holds the right to deny service, at any time.
7. I agree that any films, sound or other recording of my adventure activity can be used in any films, sound or other recordings as TASB deems fit, without my consent.
8. I understand that if I do not attend or ride, there will be NO REFUND of any monies paid.
9. I agree that this waiver and release is a Deed which is governed by the laws of Malaysia.
10. I am over the age of consent (being 18 years of age), or I am accompanied by a parent or guardian who is over the age of consent, who has signed the waiver and release on my behalf.
